TERMS and CONDITIONS:








1. The purpose of this MoU is only to express the intentions of the party and is not intended to be legally bound on either parties.

4. The course details of specific courses / development programs will be proposed to KCASC individually and the specifics (duration, fees and other details) will be agreed upon by both parties at that time.
5. Each party recognizes that the other party has, may have or will have arrangements of a similar or different nature with other parties.
6. Each party shall keep confidential any information that it receives from the other party. Publication of any material that is jointly developed by the two institutes will be considered as confidential and will not be shared in any public forum or with any third party, without prior consent/ approval of the other in writing, obtained from the authorized signatory.
7. Nothing contained in this MOU shall by express grant, implication, Estoppel or otherwise create in either party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights and designs) of the other party.
8. This MoU shall remain in effect for the **period of three years** from the date of its execution by both parties.
9. Either party may terminate this MoU by giving calendar 30 days' notice in writing to other party.
10. The terms of co-operation may be extended beyond the terms mentioned in this MoU, on the basis of discussion & upon mutual agreement.
11. Dispute Resolution: Any disputes and differences with respect to or in relation with this MoU shall be settled by mutual discussions of the parties within a period of 30 days. In case parties fails to amicably settle the disputes or differences within the aforesaid period, this MoU shall stand terminated.

AMENDMENTS:

This MOU may only be amended by mutual agreement evidenced in writing by a duly authorised representative from each of the parties.
