



Report:

Date: 20 and 21 December 2019

Report:

The hackathon was inaugurated at the hands of Principal Dr. Ashok Agrawal in the presence of Dr. Muckta Karmarkar Vice Principal, Dr. Jayashri Bangali, IQAC Coordinator & B.Sc(CS) Coordinator, Mentors and Judges, Mr. Amit Bagaitkar, Director-Product Engineering Harman International, Mr. Tushar Chaudhari Program Manager, Harman International, Ms. Madhuri Deshpande, HOD Computer Science, S. P. College. Students were given 8 problem statements out of which they had to choose only one problem for implementation. The problem statements were based on daily requirements of various categories like food wastage management for canteen, bus routing management, car pooling etc.

After the students selected the problem statement they were given time to think and understand the problem. A mentoring session was conducted where the students could ask doubts about the problem. The mentors even guided the students of what is expected from the problem.

Teams were given 3 hours to understand the problem and design a solution for the problem after which they were evaluated.

On the second day, a progress of the students after getting the feedback and suggestions from the judges was checked. Till the next evaluation the students did coding, redesigning of the problem if suggested. In the final evaluation the students presented their problem statement, their understanding of the problem, scope considered and assumptions made for solving the problem along with the team break down structure.

Total 12 teams from various colleges and Universities participated in the competition.




