Kaveri College of Arts, Science & Commerce having its registered office at S.No. 36, Ganesh Nagar, Near CDSS, Pandurang Colony, Erandwane, Pune, Maharashtra 411038. (hereafter referred in as Kaveri College)

“National Securities Depository Limited” and “**Kaveri College of Arts, Science & Commerce, Pune**” may be referred to as ‘Party’ individually and as ‘Parties’ collectively, as the context may require.

Now this agreement witnesses, governs and binds the parties as follows for the following activities:

- 1. Investor Awareness Program:** To spread financial literacy amongst Kaveri College students, Faculty members and staff, NSDL will organise various one day program and workshops at Kaveri College Pune campus without any fees. Students from other institute and general public may also be invited as participant.
- 2. NSDL Certification Program:** NSDL would like to collaborate and offer the certification in capital market program for 36 hours to up skill Kaveri College students / Participants on financial market domain without any fees at Pune campus. The program schedule can be decided with mutual convenience.
- 2. NSDL shall take care of resource persons, experts for conducting program.** There will be no obligation regarding honorarium, logistic, lodging, etc of resource persons / experts on the part of Kaveri College.
- 3. Market Ka Eklavya Contest:** In order to provide students with a real time market experience in a way of simulation model for investments in Capital Markets, NSDL will provide the demat login through which they can trade and get the experience of trading. NSDL will conduct Market Ka Eklavya Contest at Kaveri College, Pune or NSDL as per mutual convenience.
- 4. Kaveri College will have to provide NSDL with Infrastructure support in terms of classroom with Projector and Kaveri College Pune’s Auditorium if required.**
- 5. The dates & schedule will be finalized as per mutual convenience of the parties from time to time.**

Term and Termination:






Name of the Activity: Certification in Capital Markets

Date: 11 February 2020 to 15 February 2020

Report:

An add-on course, NSDL Certification in Capital Markets was conducted for the students of the college in association with National Securities Depository Limited (NSDL).


The course covered various modules like Money and Financial Systems, Starting with Investment, Overview of Mutual Funds, Overview of Equity, Basics of stock selection and Debt markets. Discussions and Deliberations on Inflation Concept, Banking Policies, Role of Investment, GDP, UCC, Gold Bonds, Demand and Supply and Macro and Micro Economics were done. Concepts of Primary Market and Secondary Market. Terms like IPO, underwriters, Stock Exchange, Brokers, Off Market transactions, Exchange Transactions, Settlement Guarantee Fund, Depositories (NSDL/CDSL), Broker pool Account, Repo Rate, ECS, etc. were covered. Participants were taught about the various types of Mutual Funds like Hybrid Fund, Open ended Funds, Close Ended Funds, Growth Funds, Tax Saving Funds and Pension Funds. Also, resource persons explained Fundamental Analysis of Economy and company and Technical Analysis with the help of Trends and Graphs as a basis for Stock Selection. Market Ka Eklavya Competition was conducted at the last day of NSDL Certificate Course. 23 Students presented Powerpoint Presentation on stock Market Analysis. Mr. Sandip Varma Assistant Manager NSDL and Mr. Tejas Patil from Department of Finance, Government of Maharashtra Mumbai. were in the panel for judging the Competition. After the competition Valedictory function was started at 2.00 pm. Student Representative Mr. Nikhil from TYBCOM shared his experience about NSDL Program. Principal Dr. Ashok Agrawal expressed his views and announced the second batch will be conducted soon. Prizes were distributed to the Winner and runner ups in the presence of Principal Dr. Ashok Agrwal, Vice Principal Dr. Muckta Karmarkar and Mr. Tejas Patil. 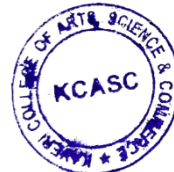

The NSS Unit of the college along with our academic partner NSDL organized a financial literacy workshop on 31st December 2020 from 12.30 pm to 2.30 pm.

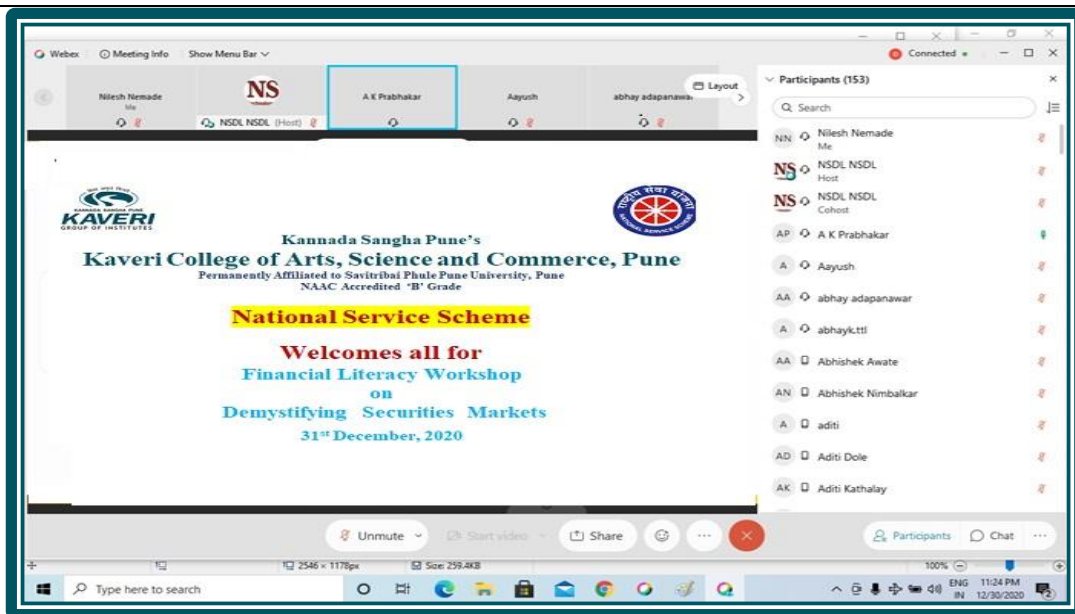
Mr. Nilesh Nemade, NSS Programme Officer introduced the programme and welcomed the resource persons and the students.

The resource persons for the workshop were Mr. Marlin Corriera from NSDL and Mr. A.K Prabhakar, Head of Research IDBI Capital Markets and Securities Ltd.

Mr. Marlin Corriera talked about financial securities like equity shares, preference shares, etc. He talked about investing, stock markets, etc. He also talked about exchange traded funds, and the power of compounding in the stock markets. He gave the example of Infosys Ltd about how a meagre investment could gain huge returns. He appealed to the students to invest early.

Mr. A. K Prabhakar talked about dematerialization and the procedure of opening a 'Demat Account' and gave detailed information about it. He emphasized on the 'Role of Depository' in the capital market. He also made the students aware about working of Indian Capital market and explained the benefits of investing in the stock market.

After the session, it was opened for questions and answers. The students enthusiastically asked questions to the resource persons. More than 150 participants participated in the workshop. Session was very informative and students enjoyed it a lot.

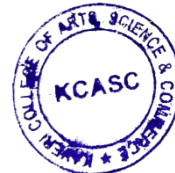

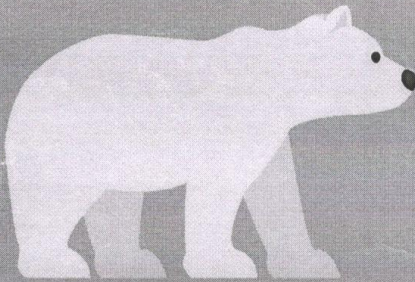

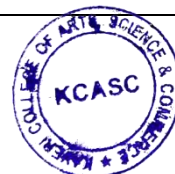
